REPORT ON PUPIL PREMIUM GRANT 2016 - 17

PUPIL PREMIUM - KEY FACTS

- Introduced April 2011
- The Pupil Premium is allocated to children from low-income families who are 1. Currently known to be eligible for Free School Meals (FSM), 2. Children who have been looked after by the Local Authority continuously for more than six months (LAC) 3. Children whose parents currently serve in the armed forces (Srv) 4. Children who have been adopted
- Schools are free to spend the Pupil Premium as they see fit. However they will be held accountable for how they have used the **additional** funding to support pupils.
- From September 2012, schools are required to publish information about how they have used the Pupil Premium.
 This will ensure that parents and others are made fully aware of the attainment of pupils covered by the funding.

PRINCIPLES FOR USE OF PUPIL PREMIUM

- The Pupil Premium will be used to provide additional educational support to improve the progress and to raise the standard of achievement for these pupils
- The funding will be used to narrow and close the gap between the achievement of these pupils and their peers
- As far as its powers allow the school will use the additional funding to address any underlying inequalities between children eligible for Pupil Premium and others
- We will ensure that the additional funding reaches the pupils who need it most and that
 it makes a significant impact on their education and lives.

FOCUS OF PUPIL PREMIUM SPENDING

- To ensure that disadvantaged pupils make progress broadly in line with pupils who have no FSM entitlement.
- To target more able pupils (MAPs) on FSM to be working at greater depth at the end of KS2
- The provision of support for pupils on FSM to improve behaviour for learning.
- The provision of outside professional services to identify and address barriers to learning

IMPACT OF SPENDING

- The performance of pupils eligible for pupil premium in all three subjects was broadly in line with the national average for pupils not eligible for pupil premium (2017).
- Free school meal (FSM) pupils outperformed non FSM in Reading and Writing
- FSM pupils outperformed non FSM pupils at greater depth in Maths and Writing
- Progress from KS1 to KS2 for FSM pupils was greater than non FSM in Maths and Writing.
